

ADOPTION STATEMENT Planning Obligations & Affordable Housing Supplementary Planning Document (SPD)

Formal amendment to document - addition of new wording at Paragraphs 4.46 to 4.54

Town and Country Planning (Local Planning) (England) Regulations 2012

In accordance with Regulations 14 & 35 of the Town and Country Planning (Local Planning) (England) Regulations 2012, notice is given that Chichester District Council adopted an amendment to the Planning Obligations & Affordable Housing Supplementary Planning Document (SPD) on 19 July 2016.

The SPD contains guidance on Chichester District Council's approach towards seeking planning obligations within the local plan area when considering planning applications. It supplements policies within the Chichester Local Plan: Key Policies 2014-2029, and forms a material consideration to be taken into account when determining planning applications.

The amendment to the SPD is contained in an additional section that has been inserted at Paragraphs 4.46 - 4.54 of the revised document. The additional wording sets out the Council's intended approach for securing development contributions to mitigate additional traffic impacts on the A27 Chichester Bypass.

The wording added to the SPD has been subject to public consultation. The comments received in respect of the consultation and the Council's response can be viewed in the consultation statement published on the Council's website.

Any person who is aggrieved by the decision of the Council to adopt the amendment to the Supplementary Planning Document may apply to the High Court for permission to apply for Judicial Review of the decision. Any such application must be made promptly and in any event not later than 3 months after the adoption of the document, which was 19 July 2016, as required by Regulation 11 (2(c and d)) of the Town and Country Planning (Local Planning) (England) Regulations 2012.
