Information Statement for Referendum on 1 July 2021




Introduction

A referendum on the Rogate & Rake Neighbourhood Development Plan will be held on Thursday, 1 July 2021. The referendum will be conducted based on procedures, which are similar to those used at local government elections.

The question to be asked in the referendum is:

'Do you want the South Downs National Park Authority to use the neighbourhood development plan for the Parish of Rogate to help it decide planning applications in the neighbourhood area?'

The neighbourhood area is the entire Parish of Rogate and is marked on the map below (boundary in red):



Can I vote?

You can vote in the referendum if you live in Rogate and:

- you are registered to vote in local council elections; and
- you are 18 years of age or over on Thursday, 1 July 2021.

You have to be registered to vote by Midnight on 15 June 2021, to vote in the referendum. You can check if you are registered to vote by calling 01243 521010.

Referendum Expenses

The Referendum expenses limit that will apply in relation to the Referendum is £3084.75. The number of persons entitled to vote in the Referendum by reference to which the limit has been calculated is 1225.
